## CHANGES FROM JANUARY 1, 2013 DIRECTORY

1. Aqua Illinois, Inc. purchased the water assets of Nordic Park Water & Sewerage Disposal Company, Inc. on November 21, 2013 (Certificate of Public Convenience and Necessity issued in Docket No. 13-0155 on September 18, 2013). The Commission approved Nordic Park Water & Sewerage Disposal Company, Inc.'s permanent abandonment of the provision of water service to its service territory.
2. Aqua Illinois, Inc. purchased the water and wastewater assets of Woodlawn Utilities Corporation on November 21, 2013 (Certificate of Public Convenience and Necessity issued in Docket No. 13-0155 on September 18, 2013). The Commission approved Woodlawn Utilities Corporation's permanent abandonment of the provision of water and sewer service to its service territory.
